1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Introduction

Saraswati Mandir Night College of Commerce and Arts was established in the year 1992. This is the first grantable Night College of Commerce and Arts in the vernacular medium in Pune, and permanently affiliated with Savitribai Phule Pune University. The college's parental institute, Saraswati Mandir Sanstha, was established in 1920. A great people's group of intellectuals and great visionaries like Late C. G. Karve, Late Y. R. Date, Late G.N. Tilak, Late M. K. Bhawe, and Late A. N. Palkar came together for this novel to work with the aim of opportunity of education and spread of education at the grassroots. The underprivileged students and working people fulfill the thirst of education. The motto of this institute is 'Dnyanam Balanam Balam' (Knowledge is Power). Sanstha started its first night school on the 1st August 1920. The Saraswati Mandir Sanstha is 102 years old, and has a rich history and experience in the field of education. These visionaries recognized the need of society and started a school for society, spreading the light of education by night. This need was relevant before 102 years ago and it also has relevance over 102 years. One of the goals of Sanstha is to give education from KG to PG to the students. The parental institute runs night school, night junior college, night senior college, and day junior college and school too. Under the guidance of eminent educationists, Late Mukundarao Kulkarni, Late D. M. Ambekar and Late Dr. Y. G. Shindes' relentless efforts in college started with 2 programmes with 30 students. Now the college has 2 UG and 2 PG programs. The total number of students is more than 1000.

The college is recognized by UGC under Sections 2(f) & 12(B) of the UGC Act 1956. The college offers 2 UG and 2 PG programmes in Commerce and Arts. The college has been re-accredited for the 2nd cycle by NAAC with a 'B' grade in the year 2017. In the academic year 2019-20, college got permission for F. Y. B.Com 3rd division, F Y B A 2nd division and P G course M A. in Economics. To fulfill the objectives of the college, the college conducts co-curricular, extracurricular, and extension activities for the overall personality development of the students. The students learn through workshops, lecture series, competitions, celebrations of important National-International days, field, etc. which are arranged by the college every year. Teachers encourage students to take part in programmes which are organized by other colleges.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Curricular Planning and Implementation: The College is affiliated with Savitribai Phule Pune University, Pune, so the college follows the CBCS 2019 pattern curriculum prescribed by the university. The College has a well-planned, effectively delivered, and documented process for University- prescribed Curriculum. At the commencement of the academic year as per the university schedule IQAC college committee prepared the academic calendar. Teachers prepared the semester-wise teaching plan. At the beginning of the academic year, teachers conduct a bridge course for the students. College conducted Interdisciplinary lecture series for

commerce and arts programs students.

Academic Flexibility: Students can opt for specialisation under the B.Com and BA programmes. Savitribai Phule Pune University introduced the Choice Based Credit System in 2019. The college offers 2 UG and 2 PG programmes with the Choice Based Credit Pattern.

Curriculum Enrichment: Savitribai Phule Pune University offers courses related to cross-cutting issues like Professional Ethics, Gender Equality, Human Values, Environment, and Sustainability in UG-PG programs. At the college level, several extensional, co-curricular activities are conducted by the various committees. Some activities are included in the courses' curriculum such as experiential learning, project work/ field work/internship. For gender equity awareness, the college conducted a webinar, and workshop on the same theme.

Teaching-learning and Evaluation

Student Enrolment and Profile: The college has the process of admitting students to the college through a transparent, well-administered mechanism. The college follows all the norms of State and Central Governments while admitting the students.

Teaching Learning Process: The faculty adopts innovative teaching methods like Group Discussions, Projects, Chalk and talk. The college teachers provide video lectures, a question bank, syllabus, notes, learning material, video lectures through LMS. LMS facility provided by Savitribai Phule Pune University, Pune.

Teaching Profile and Quality: The college is particular about recruiting faculty with the required qualifications as per the guidelines of the UGC. In our college, more than 50% of teachers are with Ph.D. holders and out of them 40% are Ph.D. guides. The average experience of all teachers is around 20-25years.

Evaluation Process and Reforms: Internal evaluation is robust and conducted as per the academic calendar prescribed by Savitribai Phule Pune University, Pune. The Programme Outcomes and Course Outcomes evaluation was carried out through internal and external examination. The formative assessment process carried out includes tests, tutorials, home assignments, seminars, quizzes, presentations, projects, etc.

Students Performance and Learning Outcomes: The Choice-Based Credit System introduced by Savitribai Phule Pune University and adopted by the college from academic year 2019-20. The curriculum of each subject has been designed on outcome based on SPPU. All Programme Outcomes (POs) and Course Outcomes (COs) have been communicated to the students for the awareness of the related courses in the Induction Program and on the college website.

Research, Innovations and Extension

Resource Mobilization for Research: One of the faculties of our college undertakes 4 minor research projects funded by ICSSR.

Innovation Ecosystem: In the college, some activities conducted by the departments of the institute have formed an ecosystem for innovation, creativity, transfer of knowledge, and entrepreneurship development.

Research Publications and Awards: The 34 research papers published in reputed journals. Around 15 chapters in edited books, research papers in national and international proceedings have been published during the last 5 years.

Extension Activities: The college organized workshops/seminars/conferences on different issues for the students.

Collaboration: The College has MOU with Multiple Institutes for Cooperation and Promotion Cells from English Dept.

Infrastructure and Learning Resources

Physical Facilities: The college has 41800 sq.ft. on the 2nd floor of the building. The college has a sufficient parking facility for both two and four-wheelers. The college has 17 classrooms with good air ventilation, lights, and fans, A. V. Hall with LCD projector, a separate common room for girls, a fire extinguisher, an inverter for all classrooms, an office facility in the office, and an examination department. The campus is under CCTV surveillance. Solar panels are installed on the college classroom's roof.

Library as Learning Resource: Library has reference books, an encyclopaedia, and newspapers with a spacious reading hall for students and teachers.

IT Infrastructure: Computers are used for administrative work in the office with a speed of 10-5MBPS. The college has BSNL 6 broadband connections with an unlimited subscription.

Maintenance of Campus Infrastructure: The college regularly takes care of the maintenance of classrooms and electrical equipment. The college has appointed an independent person to clean the rooftop solar panels.

Student Support and Progression

Student support: In the last five years, 99 students have received various government scholarships. The college parental institute helps for those students who get merit in the 12th examination. Prasad Narayana and Rekha Krishnan's NGO 'The Power of One' provided financial assistance to needy students. The college provided financial assistance under the Earn and Learn Scheme of SPPU. The Psychology Department provides support to the students and for those who need personal counselling for their problems, study-related problems and personality development.

Student Progression: Shri Prashant Ahire got a Gold medal in the M A. Marathi at SPPU, Pune. He completed his bachelor's degree at our college only.

Student Participation and Activities: College arranges the activities for students' overall personality development to serve the objective of the college.

Alumni Engagement: Parental institute of the college has a common SARASWATI MANDIR MAJJI VIDYRTHI SANGH for all branches of past students. Every year on 26th January, the parental institute arranges a reunion for all past students. Our students take part in this get-together.

Governance, Leadership and Management

Institutional Vision and Leadership: The college has a well-defined Vision and Mission statement. As mentioned in the mission statement, everybody in the college is motivated to spread the light of education by night. The Principal of the college has complete authority over the functioning of the institute. The college has various committees for smooth functioning to continue our vision.

Strategy Development and Deployment: The college was established in the year 1992 with an uncommon mission. With systemic planning, the college is making progress. The strategic plan of the institution for society is to enhance the academic standards and culture, to increase the number of enrolled students. Teachers are motivated to accept the challenges of the new educational scenario, technology, and changing expectations of the learners, research publications, research projects, and research activities. The students/staff members are encouraged to participate in curricular/co-curricular and extension activities.

Faculty Empowerment Strategies: Faculty performance assessment is done by the self-appraisal forms. In the self-appraisal form, teachers are required to give his/her self-evaluation of the academic co-curricular, extra-curricular, examination duties, and research and publication work. Every year the confidential reports of non-teaching staff are collected and evaluated by the Office Superintendent and the Principal.

Financial Management and Resource Mobilization: The main source of finance is the grant from the state government for salary, fees received from students and funds received from the university for various extension activities. The prepared budget is approved by the College Development Committee. After being approved by the College Development Committee, the funds are utilised as per the budget for the next year. Internal and External Financial Audit is conducted by the college. External Audit is conducted by Medadkar & Co. Chartered Accountant.

Two Best Practices

1) A State-Level “Keshavsut Karandak” Poetry Competition and Workshop’.The college has organized this activity since 2005. Initially, it was a self-funded activity. The college is receiving funds from the university to organize this activity since 2010. To develop students’ poetic and literary creativity, to promote and create awareness about Marathi poets among students, and to provide training in various forms of Marathi poetry through workshops. It is an inter-collegiate state-level competition and students eagerly wait for this competition.

2) Akshya Urja. For the protection and conservation of the environment, the college installed 28 solar panels and shifted to alternative energy. This is again a self-financial activity. Now the college has 00 electricity consumption and the electricity bill is Rs. 384 only.

Institutional Distinctiveness: The college started with an uncommon mission. Saraswati Mandir Night College of Commerce and Arts is located in the heart of Pune city. It is surrounded by tourist places like Shaniwarwada, Vishrambag Wada, Raja Kelkar museum, hotels, and an education hub. The college provides an opportunity for the needy and downtrodden students who work in the daytime and come to drench their thirst for education in the evening time.

Effective curriculum planning and delivery

- The objective of the institute is to impart quality higher education to working and disadvantaged students and explore the best possible way for student progression. The institute is affiliated with Savitribai Phule Pune University and strictly follows the university's prescribed curriculum and takes more efforts to achieve academic excellence and core competency by adopting academic flexibility measures. The college follows the guidelines laid down by the State Government of Maharashtra and the University. Each faculty completes the syllabi as per the time allotted for each unit which is given in the syllabus.
- **Academic meetings**-At the commencement of the academic year the Principal conducts a brainstorming session concerning teaching-learning activities keeping in view the outcomes of the previous year.
- **Academic calendar**- At the commencement of the academic year, the IQAC prepares the Academic Calendar. It helps to fulfil the objectives of the curriculum delivery as per the schedule of the university. It incorporates every activity which is organized during the academic year covering co-curricular or extra-curricular.
- **The Orientation Program** is scheduled for the students to provide an insight into the curriculum regarding examination patterns, co-curricular, extra-curricular, and extension activities which organized in the college. Rules and regulations regarding the use of the library and the overall code of conduct of the college are explained to the students.
- **The teaching plan** is prepared in advance at the beginning of the academic year with every element of the syllabus. All faculties take care of completing the entire syllabus as per the teaching plan
- **The timetable committee** prepares a class-wise timetable as well as a master timetable including subjects and the name of the subject teachers
- **Teaching methods**- Different Pedagogy in teaching as blended lecture methods, participative, and experiential learning, apart from Chalk and Talk are adopted in curriculum delivery.
- **Faculty development programs**- Faculties are trained regularly through Orientation programs, refresher programs, FDPs and online workshops to enhance their ideas to impart global knowledge and life skills to the students

Conduct continuous internal assessment

The college is affiliated to Savitribai Phule Pune University (SPPU). The college strictly follows the guidelines of Continuous Internal Evaluation (CIE) prescribed by SPPU. The college has appointed the College Examination Officer (CEO). CEO has led the Examination committee. CEO calls the meeting for the planning of Continuous Internal Evaluation for UG and PG programs. The examination committee plans the tentative timetable for the internal exams, oral/ practical exams and written exams. In advance

examination committee communicates the dates of the Examinations to faculties and students. Therefore, the faculties can complete syllabi in time and accordingly set the papers for internal exams.

In the academic year 2017-2018, 2018-2019, there was annual pattern in the examination. The 20 marks for the internal exam and the 80 marks for the university exam. College Examination committee conducts 60 marks exam for two hours at the end of the first term that converted into 20 marks

From the academic 2019-2020 choice-based credit system is implemented for the first year of all courses and exam pattern is changed.

Evaluation will be done continuously, three times during each semester. Internal assessment will be of 30 marks. The colleges need to adopt any three of the following methods for internal assessment: - Written examination, Quizzes, Presentations, Assignments, Oral examination etc.

1.3 Curriculum Enrichment

1.3.1 Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum

Response:

The objectives of the institute are to act as a catalyst for empowering students to become better human beings with their spirit of nationality and strengthen the student's abilities for their overall personality development. Our institute is affiliated with Savitribai Phule Pune University. Here we follow the curriculum of the University. In the curriculum of the University, all points like Professional Ethics, Gender, Human values, Environmental, and sustainability are already included. In the Compulsory English subject of FYBCom, the lesson of Indra Nooyi focuses on professional and personal work ethics. Oscar Wilde's story 'The Rose and Nightingale' reveals the themes of compassion, sacrifice, and love. R. K. Narayan's story 'Engine Trouble' reveals the series of misfortunes after winning a prize. Rabindranath Tagore's poem 'Singing and Telling of Beads' possessed with a deep spiritual philosophy.

Environmental Studies is a compulsory subject for all undergraduate second-year students, related to Environment and Sustainability. Environmental Studies is an interdisciplinary course to inculcate awareness of environment protection. The course includes the study of natural resources with emphasis on renewable energy resources, the importance of conserving the present ecosystem, promoting biodiversity, perils of environmental pollution, and raising awareness on environmental and social issues.

Cyber Security, Human Rights, and Skill development are credit-based courses for PG students.

The students must understand human values and follow professional ethics in their relevant field. Various departments organized lectures on Human values, especially on Gender Equality, Women Empowerment, and skill development for the students of the college.

Choice Based Credit System w.e.f. the academic year 2019-20:

Savitribai Phule Pune University has introduced a Choice Based Credit System in the academic year 2019-20. Students need to earn two credits during the first and second semesters through the completion of two value-added courses, i.e. one course for each semester.

Our institution implements an Employability Skill Enhancement Programme for the first semester and Democracy, Election, and Governance for the second term for FYBCOM students.

From the academic year 2021-2022, Rural Community Enhancement Courses introduced to arts faculty as a choice-based credit system.

In the institute, we follow Professional ethics in teaching-learning, research, student admission, staff

recruitment, and implementation of government policies and University policies. Detailed terms reflected in the curriculum of subjects like Economics, Political Sciences, Psychology, History, Geography of Arts Faculty and Business Management, Banking and Finance, Business Laws, and Accounting and Finance in Commerce Faculty. In the BA Psychology course, the concepts of Professional Ethics- Leadership, Communication process are highlighted. Gender issues, Gender and Health, Gender and Happiness, Human Values- Positive emotions and wellbeing, Flow experience, Environment and sustainability- for sustainability, Stress-Coping behaviours, Quality of life and Health behaviour, Personal Goals, Mindfulness, and wellbeing are included in the curriculum.

Education is the best platform to bring changes to society. The curriculum consists of courses with one credit each, designed to create awareness on cross-cutting issues like gender sensitization, and environment and sustainability. These courses train students to apply analytical thinking in solving issues, inculcation of values which are the guiding principles of life, be it physical, mental, or social wellbeing addressed by the Value Education Course.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The college has conducted internal evaluation process as per norms of Savitribai Phule Pune University, Pune. For the internal continuous assessment of students, the college conducted tests, tutorials, home assignments, group discussion, quiz and presentation with related topics in every semester as per University guidelines.

The Academic Planning Committee and Examination Committee prepared the internal theory and practical examination timetable as per University examination circular. Under the IQAC guidance, in advance it is communicated to the students by displaying it on notice board as well as sent through WhatsApp group also.

Teachers also communicated necessary guidelines to students in classroom and they insist students to fill examination form before the due date given by SPPU.

After the result declaration, College Examination Committee analyzes the result and intimated to students to improve the performance in the next examination.

The internal evaluation is performed as per examination circular given by SPPU.

The college has Examination Committee and Examination unfairness Committee to solve the examination related problems of students.

The grievances related to external examination of SPPU like absentee in paper, wrong mark entry, hall ticket issue, mistake in student's name and subject were resolved by College with the help of Examination Department.

Coordinating with examination committee, the IQAC reviews the evaluation process. The grievance redressal process is done on both the levels, university and college. At university level, the student can apply to the university through online mode and the hardcopy of this application is to be submitted to the college for obtaining the photocopy of the answer sheet. Similar process is applicable for revaluation and rechecking. The result is sent by the university to the college and college gives it to the student. The college follows the rules and regulations laid by the University for Evaluation and its redressal. All the issues are resolved with communications with University authorities through University webmail. In this way, the grievances of students regarding the assessment and evaluation process are resolved in steps, first at the institute level and then at University level depending upon the nature and intensity of the grievances. The Examination Department of the college displays internal evaluation scores on the notice board.

The Examination Officer in consultation with the Principal resolves it and fixes the responsibility. In case of evaluation, students are allowed to ask for photocopies of answer sheets on the fixed payment prescribed by University. The students are also allowed to ask for revaluation of answer sheets within fifteen days after the declaration of result.

In the pandemic situation those students who faced the problem of submission of paper in the internal examination due to poor connectivity of network for them again college conducted examination and gave another chance to the students for appearing the examination.

During the first lecture in the classroom, every teacher also gives information regarding the Programme Outcomes, Course Outcomes, and various opportunities after the completion of the program.

As well as teachers also deliver information to students regarding various competitive examinations like M.P.S.C., Banking, C.A., Police Department, etc.

The method employed for the evaluation of Programme Outcomes and Course Outcomes is given below.

The evaluation was carried out through internal and external examination. The formative assessment process carried out includes tests, tutorials, home assignments, seminars, quizzes, presentations, projects, etc.

The academic progress of students in this regard was monitored by the teachers. The TYBCom. Students of the Internship Program work in the industrial field and take first-hand experience. This program is scheduled for 60 hours a year. Because of this program, the students learn to earn in their careers. While talking about the Banking and Finance subject, the students of this subject work for 60 hours in their chosen finance firm as per their interests. Then it is noticed that they learn how to make passbook entries from the ledger, the process of NEFT, issue of DD, the process of RTGS, Bank deposits, online transactions of Banking etc. through their work and experience. The TYB Com students of Cost and Work Accounting work for 60 hours in the chosen firm at their convenience. In this work, they learn the practical billing, classification of market and accounting transactions, material purchases, different types of expenses, and preparation of vouchers. It is seen through the presentations of the students.

As per the SPPU examination guidelines and 2019 Choice Based Credit system pattern performance of students evaluated through University Examination and Internal Examination. After the result declaration, the examination department analyzes the result.

A student with a minimum of 35% marks can seek admission on a first come basis; the course contents are being taught in such an effective way by the teachers that, the educationally backward youth gets an opportunity to learn in the homely atmosphere of a college. Many of our students seek higher education with a big educational gap, so one may find a student aging double his co-student. While studying for the regular degree courses in vernacular medium, they are encouraged to participate in various co-curricular, extracurricular, and extension activities to achieve overall personality development, which in turn builds an educated and progressive society and a nation.

As per the mission statement, the college is committed to spreading the light of education in the life of the disadvantaged, socio-economically backward working class of society by providing higher education at night time. The college will aim or enhance the quality of the academic programs by improving the courses, strength, and infrastructure. The teacher will encourage getting new knowledge and imparting this knowledge coupled with values through interactive methods. The college will aim at perspective planning and updating its vision documents. The college provides a homely atmosphere, which effortlessly and unassumingly mingles with the ethos familiar to students coming from the weaker section of society.

The college has established a well-designed system of delegation of authority. Under this the Principal delegates different activities according to the nature of the job and type of contributions. The college delegates authority by appointing a coordinator of the unit/department and committees. These coordinators have been given operational authority and freedom to organize and implement the programs and undertake decisions. The college authority has decentralized the college governance by decentralizing the

administration. Teachers and administrative staff members represent their representatives in the College Development Committee. Through this committee, these teachers are given scope to groom their leadership. The Staff Academy coordinator looks after the academic and non-academic concerns of teachers and thus leads the staff. At the student level, students participate in various college activities like Vidyarthini Munch, Students' Welfare Association, sports, and cultural activities and get the experience of planning and implementing various activities. Alumni and experts working in social and educational fields are also included in the College Development Committee of the college. So that their knowledge can benefit the various stakeholders of the college.

The college was established in the year 1992 with 30 students and two programmes. Since its inception the college has given priority to enhancement and improvement out of these visionary approaches, now the college is a well-established and renowned institute with more than 1000 students, and four programs out of these two programmes have the permanent affiliation of Savitribai Phule Pune University from the academic year 2012-13. As per the proposed expansion plan, the college has started a new program of the M.A. Economics, 3rd division of UG under commerce faculty and 2nd division of Arts faculty from the academic year 2019-20. The Perspective Plan has incorporated the recommendations made by the Peer Team during the second cycle of NAAC. The college management has set a strategic plan with the right understanding of long-term achievement. The silent features of the strategic plan of the institution are as follows.

- To enhance the academic standards and culture.
- To increase the number of enrolled students.
- To motivate faculty members to accept the challenges of the new educational scenario, technology, and changing expectations of the society and learners, research publication, research projects, and research activities.
- To encourage the faculty for Ph.D. guideship
- To encourage students/staff to participate in curricular/co-curricular and extension activities.

For this purpose, an action plan is designed in the following manners.

The Principal is the administrative head of the institution responsible for implementing the policies and decisions of the CDC. The CDC consists of members from management, the Principal, Ex-Student, and elected members from teaching and non-teaching staff. He also looks after the day-to-day functioning of the college. The Internal Quality Assurance Cell (IQAC) is an apex body constituted as per the NAAC guidelines. It plays a pivotal role in ensuring quality sustenance and enhancement in the delivery of academic and non-academic services to stakeholders. It takes decisions in meetings, and accordingly, gives directions to Heads of departments and conveners of cells. Continual monitoring helps in quality improvement. IQAC has constituted non-statutory committees to render various kinds of services to

stakeholders. The administrative work is conducted with proper distribution of duties and responsibilities from the Office Superintendent to clerical and menial staff.

The recruitment of teachers and non-teaching staff in the grantable section is done subject to the rules of the UGC, State Government of Maharashtra, and Savitribai Phule Pune University. The method of recruitment procedure is followed as per the rules prevalent by all these organizations. Non-grant section staff is recruited through the College Development Committee and for this purpose Local Selection Committee is formed by CDC.

At present, the college has an Office Superintendent, a Senior Clerk, and a Library Attendant. Despite the insufficient number of administrative posts, the college administration is working effectively.

Teaching Staff

Faculty performance assessment is done through self-appraisal forms at the time of the Career Advancement Scheme (CAS). In the self-appraisal form, teachers are required to give his/her self-evaluation of the academic co-curricular, extra-curricular, examination duties and research and publication work done for the assessment. The teaching performance assessment of teachers is done by evaluating their teaching abilities. The Principal takes rounds during the teaching period. He observes the classes and takes reports from the students orally.

The institution follows the university-stipulated Academic Performance Indicator (API) for the faculty following UGC Regulations 2010 and four amendments thereafter for performance appraisal of teachers. Currently, the institution follows guidelines concerning API for performance appraisal of teachers contained in the UGC Regulation 2018. The IQAC collects the filled-in API forms from all faculty members. The faculty's performance is assessed on the API by the IQAC Coordinator and the Principal. The API scores along with the positive and negative aspects are communicated to the concerned faculty.

Maximum expenditure in the aided unit is on the salary of employees. The main source of this is the grant from the State Government. Fees received from students are another major source. The college endeavours to make the most of the financial resources available to the college. The college prepares a budget for every year. In the said budget, provisions are made for various things like infrastructure, maintenance, curricular and extension activities, books, etc. The prepared budget is approved by the College Development Committee. After being approved by the Development Committee, the expenditure is spent as per the budget for the next year. Goals:

- To develop students’ poetic and literary creativity
- To promote and create awareness about Marathi poets among students
- To provide training in various forms of Marathi poetry through the workshop
- To make available the platform for the interaction between students and renowned poets in Marathi

The Context:

Student Development Council organizes a state-level “Keshavsut Karandak” poetry competition for amateur student- poets. This is the only state-level competition organized by our college to develop students’ poetic and literary creativity. Participant student poets meet well-known Marathi poets and seek guidance from them. With the poetry competition, the institute also organises a workshop on poetry. Till the year well-known poets like Mangesh Padgaonkar, F.M. Shinde, Sandeep Khare, Dr. Anand Yadav, Uttam Kamble, Ilahi Jamadar, Vijay Kuwalekar, Ramchadra Dekhane, Dr Vishavas Mehandale, Laxmikant Deshmukh, Navanath Gore, and many more have guided the participants from all over Maharashtra. From its fifth year, the University of Pune also appreciated this activity and since 2010 the institution is receiving funds from the university to organise this activity.

The Practice: The college has been organizing a state-level “Keshavsut Karandak” poetry competition for

amateur student- poets from 2005 under the chairmanship of the Principal.

Evidence of Success: It is noticed that due to the competition the creativity among the teachers and students is boosted. The Context-

Solar power is a clean, renewable, and emission-free energy source. It doesn't cause pollution, prevents global warming, uses fewer fossil fuels, and promotes sustainability.

Utilization of solar energy is a naturally occurring and unrestricted source.

It is necessary to use alternative energy for environmental conservation and sustainable development. It will help to reduce environmental pollution. Moreover, given global warming, the college has installed 28 solar panels on the roof to use alternative energy.

The Practice-

This Practice is a self-funded activity. It has been demonstrated through actions that the college is committed to environmental conservation.

This is to set an example in front of the students. By doing this activity, the college has taken active steps for the protection and conservation of the environment by shifting to an alternative. After going for Net Metering for Roof-top Solar Photo Voltaic System, now we are saving Carbon emissions of 10,000 kg/ per year.

Evidence of Success-

After the completion of the necessary official procedures, within 11 months the college has completed the project. The college's electricity consumption is 1084 units in Jan 2017, Feb-2818 units, Mar 2017-72 units, and Apr-00 units. In Sep 2022, the consumption of electricity units was 123. The bill amount was Rs.1503. Now the college has 00 electricity consumption and the electricity bill amount is Rs. 384 only. Now the college is protecting and conserving the environment by lowering the consumption of electricity units and reducing the bill. With this, our project cost is about to recover.

After installation of project, Savitribai Phule Pune University, Pune has started funding for such type of activity to other institutions.

Problems Encountered and Resources Required-

Energy generation through Solar panels depends upon Sunlight to gather solar energy effectively. If the weather is cloudy, then rainy days can affect the energy system. If there are a lot of dirt and bird droppings on the panels, it affects energy generation. Taking into consideration this problem, the college has deputed a person to clean the panels regularly.

- The vision of the college is the empowerment of working and disadvantaged students by imparting education by night, for which the college has a variety of courses that enable the students to seek higher education by night while working for their livelihood in the daytime.
- In the college, there is no cut-off list as per merit. A student with a minimum of 35% in HSC or equivalent exam marks gets admission on a first come-serve basis. Conversely, a student of 90% also gets admission to our college. The course contents are being taught in such an effective way by
